

THE CHBG'S TWO-DAYS' MONOTHEMATIC CONFERENCE ON SYSTEMATIC REVIEWS AND META-ANALYSES: FROM CLINICAL RESEARCH TO CLINICAL PRACTICE

The CHBG monothematic conference was run in April on 20 and 21, 2009 at the Panum Institute, in Copenhagen, Denmark. There were between 29 and 38 people attending the eight sessions with 23 presentations.

Twenty-three to twenty-nine attendants submitted evaluation forms. The marks used for the assessment of the presenters were from 1 to 5, where 1 = poor; 2 = reasonable; 3 = satisfactory; 4 = good; and 5 = excellent.

The average mark for all the 23 presentations is 4.3. The mark of the individual presenters is given in Fig 1. The slide presentations can be found on http://ctu.rh.dk/chbg



The highest mark was given to Ronlad L. Koretz, USA, for his presentation 'Does making a test better make a patient better: surrogate outcomes in liver disease'.

The additional three general questions received an average mark of 4.2; the highest average mark was given to question No. 3 (What is your overall evaluation of the conference?), followed by 4.2 to question No. 2 (How much did the conference as a



whole fulfil the objective of facilitating learning in evidence-based medicine?), and lastly, an average mark of 3.9 to question No. 1 (How much, through the conference, did we contribute to improving your knowledge on evidence-based medicine?).

CHBG EDITORS' MEETING Copenhagen, Denmark April 23, 2009

The Editors' meeting took place in the afternoon of 23 of April at The CHBG Editorial Team Office in the Panum Institute, Copenhagen. After a short presentation on the status of the CHBG work, the meeting followed the remaining agenda items that encompassed editorial issues such as ways to improve editorial processes in terms of editors' responses, quality of submitted comments, deadlines on submission of comments, monitoring and evaluation of editors' performance, expectations ensuing from the roles of an editor, commitment of contributors, and alike. The possibility of establishing CHBG satellite groups was also discussed.

It was also agreed that reviews void of randomised clinical trials shall still be published in The Cochrane Library. In lack of randomised trials, authors may also choose to prepare reviews based on observational studies, but as a Cochrane Handbook on reviews based on observational studies has not yet been finalised, authors should be cautious in summarising the findings.

Mirella Fraquelli, Agostino Colli, and Dario Conte from Italy were invited to become CHBG editors on diagnostic test accuracy reviews and they gladly accepted. Kristian Thorlund was at that time trained to become a statistical editor, and Kristian Thorlund is now also on board.

The performance of all CHBG Editors will be evaluated in May 2010, and if any of the editors does not live up to the Groups's expectations or does not perform their duties as required, she or he will be asked to step down from the Editorial Board of The CHBG.

EVIDENCE-BASED CLINICAL PRACTICE WORKSHOP: THE ARCHITECTURE OF PROGNOSTIC STUDIES AND DIAGNOSTIC STUDIES

Gargnano, Garda Lake, Italy 30 September to 3 October, 2009

The workshop was organised by the Centro Interuniversitario "Thomas C. Chalmers", Fondazione IRCCS Ospedale Policlinico Mangiagalli e Regina Elena – Italy, The Cochrane Multiple Sclerosis Group, Fondazione Istituto Nazionale Neurologico Besta, Milan, Italy, and The Cochrane Hepato-Biliary Group, Rigshospitalet, Copenhagen, Denmark.



The workshop aimed at educating medical doctors in the basics of prognostic and diagnostic studies as well as performance of systematic reviews on diagnostic test accuracy studies. The workshop was attended by 16 participants from Italy and 12 from abroad. Additionally, there were 13 people in the faculty. The break out sessions contained group exercises based on the morning sessions. The workshop finished with an examination, and all participants obtained a diploma. Participants evaluated highly the content of the presentations and the obtained knowledge, and recommended that the workshop be repeated also in 2010. Some of the participants recommended that there should be more case stories presented and more time for discussing them.

MORE ON WORKING WITH REVIEW MANAGER 5 (REVMAN) AND ARCHIE

If you forget your password, then you can request a new password or a reminder of your Archie user name and an Archie user account from the Archie login screen (http://archie.cochrane.org/).

Having logged into Archie, you can view and edit your contact details. As an author, you can view a copy of the latest version or any previous versions of your protocols and reviews. In order to work on the review, you will need to check it out of Archie into RevMan 5. Users are strongly encouraged to find answers to their questions in 'Help' of Archie and RevMan 5 before they contact The Editorial Team office as we are overburdened with questions. From the Information Management System web site (http://www.cc-ims.net/Projects/newIMS) one can find links to other pages giving answers to questions.

LICENCE TO PUBLISH FORM

Licence to publish form is required before submitting your protocol or review for publication in The Cochrane Library. The Licence to Publish form can be downloaded from 'File' and 'Reports', and 'Licence to publish form' in RevMan 5. It is the responsibility of the contact author to ensure that all co-authors have

signed it and that it is received at the Editorial Team Office prior to the protocol or review publication.

OTHER FORMS WE REQUEST YOU TO USE

We have placed several new forms on The CHBG web site, and we kindly suggest that people use them when they wish to register a new title, or before submission of their protocol or their review to the CHBG Editorial Team office. These forms are embedded in the text within 'From title to review' and 'Contact' headings, so one should click on the word 'here' that comes within the text in order to open the respective form. Peer reviewers will also be able to submit electronically the forms for comments, which are also embedded in the text within 'From title to review' on The CHBG web site. There is also an embedded form for new members under 'Contact'.

PRESS RELEASE: WHO PROVIDES PRIMARY STATUS TO THE PAN AFRICAN CLINICAL TRIALS REGISTRY IN AFRICA

25 September 2009

The Hague/Cape Town

The Pan-African Clinical Trials Registry (PACTR) has been accepted as a primary clinical trials registry – the first World Health Organization (WHO) endorsed trials registry in Africa. This registry will feed data into the global WHO International Clinical Trials Registry Platform (ICTRP) search portal facilitating African representation in the global picture of planned, ongoing and completed clinical trials. The Registry is currently funded by the European and Developing Countries Clinical Trials Partnership (EDCTP) and coordinated by the South African Cochrane Centre (SACC) at the Medical Research Council (MRC). "We are delighted to be able to offer access to a WHO primary register to all trialists in Africa. We hope the PACTR will become the first choice for African trial registration," says Nandi Siegfried, co-director at the SACC.

In September 2004, the International Committee of Medical Journal Editors (ICMJE) stated that all 11 member journals would adopt a registration policy to promote comprehensive trial registration as a solution to the problem of selective awareness



(http://www.icmje.org/clintrial.pdf). Thus clinical trials must be publicly registered before the first participants are enrolled if the intention is to publish findings in member medical journals which include leading journals such as The Lancet, JAMA and NEJM.

Professor Charles Mgone, EDCTP Executive Director, explained that since June 2009 the African registry has expanded from a disease-specific registry to cater for clinical trials on all diseases transitioning to the PACTR. Researchers conducting clinical trials in Africa who use PACTR as their registry of choice will meet international requirements for research transparency.

Davina Ghersi, head of WHO's International Clinical Trials Registry Platform (ICTRP), says the approval of PACTR as a primary trials registry is a significant milestone in the quest for transparency. "Our hope is that the PACTR will make it easier to capture information about trials involving people in the region. We look forward to filling the gap in our knowledge about clinical trials in Africa." Since registries "provide an essential tool to assess completeness of the information about all initiated trials" and are the "necessary first step to enable identification of all trials" and the "tracking of their results" (Moja et.al.,

http://www.trialsjournal.com/content/10/1/56), having an African based registry will benefit both Africa and the world as PACTR will actively encourage trial registration.

"Registering a clinical trial greatly increases exposure of the trial and assists researchers in determining gaps in research, thus reducing the likelihood of duplication of research and wasted funding and man-power," says Professor Charles Mgone.

Dr Siegfried further says that it is the intention for PACTR to become the single reference point for clinical trials activities in Africa. "The registry will feed directly into the global WHO International Clinical Trials Search Portal, thus ensuring African representation in this global search engine". Additionally, the PACTR's database will include regularly downloaded information from the South African National Clinical Trials Registry (SANCTR) and will continue to build information sharing networks with national or other localised registries.

Background information:

In response to the need to increase transparency and facilitate registration by African researchers, the HIV/AIDS, Tuberculosis and Malaria (ATM) Clinical Trials Registry was first established in 2007.

African trialists face additional challenges in trial registration, such as limited, unreliable and costly access to the internet. Quite often, African collaborators in multi-country clinical trials need to request their partners on other continents to register the trial for them. Because of these obstacles, there is serious underreporting of clinical trials that are conducted on the African continent.

The PACTR seeks to provide feasible ways of overcoming these. It is a registry which is developed by Africans for Africans. Trials may be registered online (via the internet if access is sufficiently reliable) but they may also be registered by email, postal mail or facsimile. Registration is free, and information on registered trials is free of charge and easy to access through the registry's search function.

The book presents the statistical concepts behind the application of industrial quality control methods. Filled with numerous case studies and worked examples, the text enables the reader to choose the



relevant control chart, to critically apply it, improve it if necessary, and monitor its stability. Furthermore, the reader is provided with the necessary background to critically assess the literature on the application of control charts and risk adjustment and to apply the findings.

The book is primarily aimed at health care officials, and personnel responsible for developing and controlling the quality of health care services. However, it is also ideal for statisticians working with health care problems, diagnostic and pharmaceutical companies, and graduate students of quality control.
